CEDAR SPRINGS WALDORF SCHOOL 2019 SUMMER CAMP ENROLLMENT AGREEMENT

This agreement is made by and between the parent(s) named below and the Cedar Springs Waldorf School, Inc., a corporation organized and existing pursuant to the General Non-Profit Corporation Law of the State of California. This enrollment agreement and all required enrollment forms must be completed and received before the child may begin camp.

1. Parent(s) jointly and severally promise to pay Cedar Springs Waldorf School (hereafter referred to as "the School") the tuition indicated on the reverse.
2. This tuition agreement is for the SUMMER OF 2019. Parent(s) who withdraw their child from the program prior to the end of the class hereby agree to pay the full tuition.
3. ½ Tuition is due at time of registration. The remainder of Tuition is due in full one week prior to the beginning of class.
4. If it is necessary to take legal action to collect any amounts payable hereunder, the prevailing party will be entitled to collect all reasonable attorneys' fees and costs.
5. Should you dispute the service, fees, costs, service charges or other debt obligations and we cannot resolve the dispute amicably, the dispute shall be decided by reference to the Rules of the Bar Association located in Sacramento County, or by arbitration in accordance with the commercial Arbitration Rules of the American Arbitration Association then in effect unless we mutually agree in writing otherwise.
6. There is a charge of \$20 for a check returned due to insufficient funds.
7. Parent(s) agree to provide the School with a completed health form and any necessary student record forms as shall be required by the School or any duly constituted federal, state or local authority.
8. Parent(s) hereby authorize and give full consent to Cedar Springs Waldorf School to publish and copyright all photographs in which the child appears and which were taken while enrolled as a student in any and all programs. Continued use does not constitute an agreement to continue the child's enrollment.
9. Parent(s) agree to release and hold harmless the School, its agents and employees, from all claims, damages, or other liabilities for injuries to their child, which are not the result of gross negligence by the School, its agents or employees. Parent(s) also agree to pay the School for any damages or loss by their child to the School or school property. The School is not responsible for damages to or theft of personal property left on school grounds.
10. Parent(s) agree that a child not picked up within 15 minutes of his/her class dismissal time, that the parents may incur additional costs for childcare.
